s the leaders of Canada's largest enterprises meet for a third year in a row in Washington, D.C., the dynamics of the Canada-United States relationship continue to evolve.

Whatever may be our differences, the deep friendship and respect that bind our two peoples together provide an unshakeable foundation for our unceasing efforts to build a more secure world by confronting the threat of terrorism and to strengthen the competitiveness of our economies by making the most of our potential in North America.

The evidence of our interdependence is plain for all to see. At U.S. \$1.2 billion per day, the size of the trading relationship between our two countries soars far above all others. As the largest and most reliable foreign supplier of energy to the United States, Canada is a vital strategic partner. In the security domain, both countries share in long-standing commitments to the defence of North America and to the defeat of tyranny beyond our shores. Today, as brave American soldiers fight for peace and stability in Iraq, 2000 equally brave Canadian soldiers are being deployed to do the same in Afghanistan.

Similar values, respect for the rule of law and our concern for the security and quality of life of our citizenry, dictate that we explore new avenues of cooperation on a trilateral as well as bilateral basis. The signing of the Security and Prosperity Partnership in Texas earlier this year by Presidents George W. Bush and Vicente Fox Quesada and Prime Minister Paul Martin represents an important step forward in North American cooperation -- a step that the Canadian Council of Chief Executives strongly endorses. The subsequent progress Report to Leaders tabled in Ottawa in June signals that the three governments are solidly committed to moving forward. We at the Canadian Council of Chief Executives are equally committed to building on this momentum through continuing work both with governments and with our private-sector counterparts in the United States and Mexico.

At this year's Washington CEO Summit, we look forward to hearing provocative analysis and to discussing creative ideas about what Canadians and Americans should do next in driving our shared agenda.

he Canadian Council of Chief Executives is a not-for-profit, non-partisan association of Canada's business leaders committed to the shaping of sound public policy in Canada, North America and the world.

The members of the Council comprise the chief executive officers of 150 leading Canadian corporations. These companies administer more than C\$2.5 trillion in assets, have annual revenues of close to C\$600 billion and account for a significant majority of Canada's private sector investment, exports, training, and research and development.

Widely recognized as Canada's most influential business organization, the Council has played an important role in most of the major public policy developments in Canada over the past quarter century. In particular, it was the driving force in the Canadian private sector in the development and advancement of the Canada-United States Free Trade Agreement and subsequently the North American Free Trade Agreement.

The Council is committed to enhancing Canada's influence in the world. It has been active in promoting trade and investment liberalization multilaterally through the World Trade Organization as well as through bilateral and regional efforts. In January 2003, the Council launched its *North American Security and Prosperity Initiative* to explore bold new ideas for managing both economic integration and continental security. This initiative encompasses five pillars: reinvention of borders; regulatory efficiencies; energy security; the North American defence alliance; and development of new institutional links.

The Council continues to offer leading edge thinking on North American cooperation and strongly endorses the *Security and Prosperity Partnership* launched in March 2005 by Presidents George W. Bush and Vicente Fox Quesada and Prime Minister Paul Martin.

Most recently, the Council co-sponsored, along with the Council on Foreign Relations and the Consejo Mexicano de Asuntos Internacionales, the report of an independent task force titled *Building a North American Community*.
